To upgrade to an adult license, a junior hunter who turns 16 years of age must show proof of completing the appropriate safety course. Please mail a copy of the safety course certificate and a copy of your lifetime license to the address below.
2. Copy of Current Maine Driver's License of parent/guardian

Senior Lifetime License 65 Years & Older
The following documentation is required:

1. Copy of Current Maine Driver's License
And
If applying for a firearms license: A copy of a hunter education course from any state or province or a copy of a previous adult firearms hunting license issued since 1976.
If applying for an archery license: A copy of an archery safety course from any state or province or a copy of a previous archery hunting license issued since 1980.
If applying for a trapping license: A copy of a trapper education course from any state or province or a copy of a previous trapping license issued since 1978.
