Cardboard

Boxboard, corrugated cardboard, product and food packaging boxes such as cereal, pasta, and pizza boxes, beverage holders, paper towel cores, paper bags

Paper

Newspaper, junk mail, magazines, soft cover books, file folders, color paper, paper cartons

Plastic

Containers, bottles and jugs #1-#7 such as food, beverage, beauty, and cleaning products, detergents, dairy tubs such as yogurt and sour cream, plastic take out containers, flowerpots and trays

Large rigid plastic items such as 5-gallon buckets, sleds, soda crates, laundry baskets and kid's toys

Glass

Food and beverage containers, and jars of any color

Metal

Aluminum soda and beer cans, pie plates, trays, foil, tin cans and small steel containers

NOT ACCEPTED

Plastic bags or wrapping, window glass, mirrors, light bulbs, dishes, pyrex, ceramics, paper towels, facial tissues, Styrofoam, recyclables containing food waste, needles, syringes, VCR tapes, CDs, DVDs, scrap metal, pots, pans, batteries, hard cover books, clothing, wood/lumber, yard trimmings, 3-ring/spiral notebooks.

SCALE

Residents and property owners disposing of Construction Debris (C&D), refers to waste generated from the construction, remodeling, repair or demolition of structures, and oversized bulky waste are required to have their loads weighed. Examples of items to be weighed include, but not limited to, wallboard, sheetrock, tiles, flooring material, non-asbestos insulation, siding, plaster, roofing, shingles, and furniture. You will be required to (1) drive on the scale to be weighed, (2) dispose of your waste at the designated location, (3) proceed back to the scale to be weighed again, (4) drive to the upper office building to pay the disposal fee. Failing to pay the disposal fee before leaving the facility may result in the use of the Scale service being denied until your bill is paid.

**The disposal fee is \$0.10 per pound after
the first 20 pounds.**

The Tri-Town Transfer Station is for the benefit of the residents of Bethel, Hanover and Newry. To insure the safe and efficient use of the Transfer Station we have the following Transfer Station Sticker Requirements:

Residents/Property Owner

\$10.00 per sticker per vehicle
Proof of residency upon purchase
Your vehicle plate number will be written on your sticker.
Stickers are valid for dates listed

Short Term Rentals

A Temporary Vehicle Pass (\$5.00) can be issued to a renter once the property owner has provided the Town Office by phone or by email the name of the renter and the dates of the rental period.

Contractors

Contractors working on property in Bethel, Hanover and Newry may obtain a Temporary Vehicle Pass (\$5.00). The property owner must notify the Town Office by phone or by email the name of the contractor and the dates of the project.

All property owners and residents must purchase a Transfer Station Sticker (\$10.00) prior to the issuance of a Temporary Vehicle Pass (\$5.00).

Vehicles without a sticker or temporary pass will not be allowed access to the Transfer Station.
